



Financial Assistance is available for current Girl Scout members and may be applied toward resident or day camp sessions at GSCP2P Camps, Camp Pisgah, Camp Ginger Cascades, or Keyauwee Program Center or to GSHNC Day or Resident Camps. As you are applying for your scholarship, please keep in mind that last year the average award granted was \$125.

**Guidelines for Applying for Financial Assistance:**

- Partial camp scholarships (camperships) are available only for currently registered Girl Scouts Carolinas Peaks to Piedmont members, who participated in either the QSP or Cookie program this year. - Proof of income must be attached to this application, as financial need is a factor considered by the volunteer-lead scholarship committees. This proof of income may include a pay stub, tax information, bank statements, unemployment records, or other documentation.
- Applicants must have already registered for camp and paid the \$50 deposit, and may not have any outstanding debts to the council in order to be considered for a scholarship.
- The deadline to submit a campership application is **March 14, 2018**. Applications that are received after this date cannot be considered.
- Campers will only be considered for financial assistance for one session of camp.
- **Incomplete forms cannot be processed and will be returned for additional information. Any delay in processing my impact the opportunity to be considered for assistance.**
- Campership applications for members of the same household must be filled out separately and turned in at the same time.
- Girls will be required to submit a letter to council by September 15<sup>th</sup>, following their summer camp session, telling the scholarship committee about their experience at camp. If a girl fails to submit this letter, she will not be eligible for a campership the following summer.
