



- Camperships are only available for currently registered Girl Scouts Carolinas Peaks to Piedmont (GSCP2P) members who participated in either Fall Product or Cookie program this year and may be applied toward resident or day camp sessions at Camp Pisgah, Camp Ginger Cascades, or Keyauwee Program Center or to Hornets' Nest Council Day or Resident Camps. As you are applying for your scholarship, please keep in mind that last year the average award granted was \$212 and 78% of applicants were successful at either receiving the full amount requested or within \$50 of their ask.
- Campership applications for members of the same household must be filled out separately and turned in at the same time.
- Forms that are received incomplete will not be processed. The forms will be returned to you and you will be responsible to provide information omitted and returned before the deadline of March 13, 2019. Any delay in this process may impact the opportunity to be considered for assistance.
